Dale was ordained at Silent Friends Chapel-First Baptist Church-Dallas in 1990 and graduated from Dallas Theological Seminary with Masters of Theology with minor in Pastoral Ministry. Father of five Deaf children and grandfather of three grandchildren, Dale is married to Judith Oelfke Withrow. He currently serves in various roles at the Deaf Fellowship at Frederick Church of the Brethren in Frederick, Maryland, which has a full time Pastor to the Deaf for a congregation of approximately 80-100 regular attendees. Between 2007-2015, Dale was the supervisor of the Sorenson Call Center at Gallaudet University, then in 2011, became the Community Interpreting & Auxiliary Supervisor until 2015. He currently works as an Independent Contractor ASL interpreter in the MD//VA/DC area at Federal agencies, medical settings, and Gallaudet Interpreting.
